### Live Video Streaming of General Meetings

- Live Video streaming facility commenced by NSDL on August 26, 2016
- Shareholder can view 'Live' proceedings of general meeting from their respective locations through NSDL e-Voting portal
- Wider participation of shareholders at General Meetings





# Regulatory Guidelines for Virtual Meetings

- Companies are permitted to conduct General Meetings in virtual mode through Video Conferencing (VC) / OAVM.
- Operational guidelines to be followed as per the Companies ACT 2013.
- There should be a provision for two way communication wherein shareholders should be able to ask questions to company officials.
- VC facility should capable of allowing minimum 1000 participant on FIFO basis.





# Regulatory Guidelines for Virtual Meetings .. Contd.

- Shareholders with 2% above holding, promoters, Institutional Investors,
  Directors, KMPs, Chair persons of board committees and auditors etc.,
  may be allowed to the meeting without restrictions of FIFO basis.
- Attendance of the members through VC or OVAM shall be counted for the purpose of reckoning the quorum.

- e-Voting is mandated by Ministry of Corporate Affairs MCA for all Listed companies and unlisted companies having more than 1000 shareholders.
- NSDL started this service in the year 2012
- NSDL has successfully completed around 18000 e-Voting events.
- e-AGM was allowed by MCA in year 2020 due to Covid-19 wherein shareholders of companies can participate in general meeting of companies
- NSDL has facilitated close to 3000 e-AGM events during the Pandemic so far.
